

Camp Compliance, Safety and Policies

Compliance:

This camp complies with the regulations of the Massachusetts Department of Public Health and is licensed by the local board of health and also registered to operate in Texas.

General Safety

Campers and staff always move as a unit at all times, we use crosswalks where necessary, we avoid contact with strangers, and we never approach strange dogs or animals. Staff makes themselves aware of bees nests etc. In the event that a camper needs to be isolated from the group they will be escorted by a staff member unless they are within viewing distance.

Health

Covid-19 Protocol

FSM will be operating under Massachusetts Board of health and the CDC requirements pertaining to COVID-19 preparedness and safety while we strive to provide the best experience for our participants. We are closely monitoring the (CDC) and Massachusetts guidelines related to youth sports as well as reviewing state and local protocols and regulations to ensure compliance before moving forward with our programs. As our local guidelines on social distancing, gathering size limits and youth activities change, FSM policies and procedures listed below may change accordingly.

<u>Screening waiver:</u> FSM staff, campers, and any camper family members must sign the COVID-19 screening waiver before entering our program confirming they have not been sick or have reason to believe they have been exposed to COVID-19 within the 14-days prior to camp. Any staff member or camper who does not comply will not be allowed at camp.

<u>Daily Pre-Screening</u>: Each participant will be provided before the start of the camp with a self-monitoring of COVID19 symptoms check list form. This form is intended for self-monitoring of COVID-19 symptoms. The camp director must be notified immediately if a participant shows any of the symptoms listed on the form.

<u>Wearing Mask:</u> All coaching staff must have a mask. When playing indoor during close-contact activities, participants may be required to wear a mask. Participant is not required to wear mask when playing outdoor.

<u>Water and Sanitizing station:</u> No water cups will be available for water drinking; each participant must come to camp with their own water bottle. A designated staff will be responsible for operating the water cooler. The participants must remain six feet apart from others when approaching the water station. There will be sanitizing stations near every water station.

<u>Equipment:</u> Personal equipment will not be shared and should be properly sanitized after every camp training session. Each camper will have their own personal station for their belongings 6 feet apart from others during camp. All shared equipment will be sanitized after each session and during sessions as needed by camp staff.

Before and after snack breaks and meals, staff and participants must wash hands for the recommended 15 seconds with soap and water. When soap and water are unavailable, staff and campers will be required to use a hand sanitizer that contains at least 60% alcohol. Camp staff will provide hand sanitizer as an extra precaution, but parents should provide their child with their own bottle which should not be shared with other participants.

Field Safety:

The main concerns during training are dehydration, sunburn, and soccer related injuries such as ankle sprains, knee sprains, and accidental events such as falling, being hit by a ball etc.

To address these issues, various steps will be taken in the structure and set up of drills so as to minimize or prevent such accidents.

- Coaching staff utilizes numerous water breaks.
- Where and whenever possible we will perform in shade
- At FSMA we discourage excessive tackling.
- Sun block is provided at camp and, campers encouraged to bring their own water bottles.
- We discourage shooting on arrival unless organized and supervised by camp staff.
- We teach and encourage respect of self and respect of others.
- We ask campers and staff to always be aware of others to avoid unnecessary injuries.
- Drills and exercises are keyed towards the prevailing heat and weather conditions.
- Staff is trained to space out drills and activities in order to avoid collisions.
- Campers belongings are placed in piles away from activity to avoid tripping over them.
- Common sense, organization, and structure are the basic tools to prevention. We make the effort to ensure their availability and abundance without stifling fun and creativity.

Discipline Policy

At Ferdie's Soccer Magic Academy our policy on discipline is simple but strict.

We do not accommodate rudeness and disrespect under any circumstance.

Foul and abusive language is also not tolerated. Rude and disrespectful campers will simply be sent home and not invited back to camp. Campers will be informed of this rule at orientation.

There will be no refunds whatsoever in such cases. Physical exercises will be used at camp but not as a means to punish.

When it becomes necessary to apply discipline to a situation regarding a camper, the following procedure is followed by staff:

- 1. Re-direct child's behavior to a positive activity.
- 2. Review the rules and purpose of activity to the camper.
- 3. Notify Camp Director of unusual disciplinary problems, Director will contact parents/guardians where necessary, and as a last resort, camper will be removed from activity and in extreme case removed from camp. Parent/Guardian must pick up camper.
- 4. No camper shall be subjected to cruel or severe punishment, humiliation or verbal abuse.

Staff

At FSMA we take pride in the quality of our staff as decent members of the community. 90% of our staff members were former campers, ensuring that they believe, understand and can demonstrate the values of our program. We primarily seek individuals who can model elements of successful living in society. Pleasantness, respectfulness, caring, responsible, child loving and soccer loving. In that order.

CORI and SORI Background Checks

- All Employees of FSMA must submit information to provide a Criminal Record Information background check and a Sex Offender background check from SORI board.
- No employee shall have unsupervised contact with any camper in training without providing the above.
- Parents can request more information regarding staff by contacting the camp director.
